Notice of delay to works on the A413

High Speed Two (HS2) is the new high speed railway for Britain.

As part of HS2's continued programme of surveying works in your local area, we recently sent you a letter about the need to carry out investigations into the utilities running below the ground in the location shown on the map.

We had expected these works to start on **Monday 30th July**. Unfortunately work has been delayed due to problems our subcontractor is experiencing that are beyond their control. The works will now start on Monday 20th August and take five days to be completed.

What will we be doing?

Trenches will be dug across each side of the road to a depth of 1.5ms using both hand tools and powered machinery by a team of three workers and a supervisor.

Although the digging of the trenches will only take place from 8am-6pm Monday to Friday, traffic lights restricting the traffic to one lane will need to remain in place for the duration of the works for safety reasons. This is to protect the health and safety of road users and the workers. These works have been scheduled in school holidays to reduce the impact on your travel times.

We are carrying out these works with the amended start date under permission from Buckinghamshire County Council's Transport Department and will comply with all their requirements.

Once the investigation works are completed all signage will be removed and the trenches will be filled in. Fresh tarmac will be laid and the road returned to a safe condition.

Duration of work

The works will start on Monday 20th August and finish on Friday 24th August.

Normal working hours: Monday to Friday 8am-6pm.

What to expect

What we will do

Manage any impacts, such as traffic delays and noise with the aim of reducing or removing them.

How may this impact you?

There will be delays to your travel as the traffic lights will mean journeys will take longer. We are aware this is a busy and important route between Wendover and Great Missenden, so the lights will be closely monitored.

We will make every effort to minimise the duration of the works to reduce this disruption if we can do so safely.

There will be some noise during these works from a powered saw which will be used to cut the tarmac and an excavator which will dig the trenches. As the investigation works will be restricted to the hours of 8am and 6pm Monday to Friday, you will not have noise outside of these times.

There will be some works vehicles required to visit the site. If there is material (soil, tarmac etc.) that needs to be removed then this will be done by a 20 tonne 'grab' vehicle visiting at off-peak times (between 10am and 3pm).

Silencing will be used on machinery where this is an option and equipment will be maintained to the highest standard to reduce noise and vibration.


